The Task Force appointed DCCED Commissioner Hladick to chair the task force and Julie Decker to be the vice-chair

Agenda was reviewed and the following changes were suggested: Combining the essential elements of the comprehensive plan and the advisory committees

#### **Business:**

AO 280 was reviewed and the difference between mariculture and aquaculture was discussed. The group discussed items that they wanted to do

Get a mission statement

Assemble a press release with what the task force is about

Address the issues in phases: comprehensive plan for the next 5-10 years and map out short term and long term goals

Determine the roadblocks and successes and find ways to address the roadblocks and highlight the successes

Identify exactly what is the Mariculture Task Force and how is it difference from other task forces?

Implementation plan of something real- who are we and what do we do

Encourage Stakeholder Sustainability- if you want this to succeed, it must be stakeholder driven the state cannot drive

Develop a timeline for completion of the plan

Julie mentioned that she has compiled a binder of resources that she will mail to all task force members within the next few weeks

Public Comment: Anthony Lindoff stressed the importance of learning from our history but that the task force should look at changing the culture/ attitude. We are decidedly Alaskan and the things that work for other people in other places, don't necessarily work for us. We need to appreciate our uniqueness

Sam stressed the importance of actionable items. Here's what you can do

Heather- introduced the idea of species specific planning; having a breakdown of region and species in the final document

Jeff posed the following important question: who's going to write it?

Sam suggested that someone would do the initial assembly and then brings it forward to the group

Conversation about how to outline the plan

Heather suggested a species driven outline

Have the advisory committees outline their sections and then bring their findings back to the group

Sam suggested that instead of individual species, we split it by type of operations (aquatic farming of indigenous invertebrates, fishery enhancement of indigenous invertebrates, or aquatic farming of algae's) so that it would give more of a broad overview.

The outline should make sure that everyone in industry has a voice
