Miscellaneous Business

1. Chignik River Escapement Goals

The Alaska Department of Fish and Game (ADF&G) provided an overview of a recommendation to move from an early run Chignik River sockeye salmon sustainable escapement goal (SEG) of 350,000 to 400,000 fish to a biological escapement goal (BEG) of 350,000 to 450,000 fish. No board action.

2. Aleutian Islands (Area O) Golden King Crab Update

ADF&G discussed recent interest in harvesting golden king crab in state waters of the Aleutian Islands by individuals who do not hold federal crab individual fishing quota (IFQ). ADF&G informed the board that non-IFQ holders may legally harvest golden king crab in state waters of the Aleutian Islands and that the department would manage both IFQ and any potential non-IFQ harvest to remain at or below the total allowable catch. The department informed the board that this may result in lost harvest opportunity for existing crab IFQ holders. No board action.

3. Motion to Rescind

Following the recent decision by the board to rescind a previous action, Boards Support discussed the potential need to develop criteria for the board to follow when considering rescission of a previous board action. Boards Support will provide a draft policy for review. No board action.

4. AC Minutes Provided to the Board

Prior to the October 2013 Joint Board regulatory change, advisory committees (AC) members who attended board meeting on behalf of their AC were required to submit approved AC meeting minutes prior to the board meeting they would attend. Boards Support pays for the travel costs of AC members attending board meeting on behalf of their AC and required completed minutes before attending board meetings. The new regulation requires advisory committee minutes to be provided at the discretion of the board. Boards Support is seeking guidance from the board as it implements this new regulation. Boards Support will provide a draft policy for review. No board action.

5. Chignik In-River Objectives.

The board took action to codify a management measure first established through board intent language adopted in 2004. The management measure is intended to ensure inriver harvest opportunities above the Chignik River weir. To do so, the department shall manage for 50,000 sockeye salmon, in addition to late run escapement needs, which shall be comprised of 25,000 fish in August and 25,000 fish from September 1-15. The board found a Board Generated Proposal was warranted and adopted record copy 15 as a proposal. The board carried the proposal 7-0.
