(This proposal was also be considered under the Unit 23 management area.) 29 Allocate 50% of the Unit 23 moose permits for DM875 to guides. F 30 Establish a harvest objective for brown bear in the Noatak National Preserve. Develop a Unit specific Amount Necessary for Subsistence finding for wolves in each Unit 13 in the Arctic Region. (ANS for Unit 23: 10-30.) This proposal was also considered and CA amended under the other management areas. Close nonresident trapping seasons for certain species in the Arctic Region Units. DA (Deferred to the Statewide, 2012 meeting as amended to apply statewide.) Close nonresident fur animal hunting seasons for certain species in the Arctic Region Units. DA (Deferred to the Statewide, 2012 meeting as amended to apply statewide.) Barrow Area - Unit 26A C Reauthorize the antlerless moose season in Unit 26A. Add Unit 26A to the list of areas where a resident brown bear tag is not required for hunts. CA (Amended to include Unit 18.) Develop a Unit specific Amount Necessary for Subsistence finding for wolves in each Unit CA 13 in the Arctic Region. (ANS for Unit 26A: 4-8.) This proposal was also considered and amended under the other management areas. 33 Open the wolverine hunting season earlier in Unit 26. <u>F</u> Close nonresident trapping seasons for certain species in the Arctic Region Units. 14 DA (Deferred to the Statewide, 2012 meeting as amended to apply statewide.) Close nonresident fur animal hunting seasons for certain species in the Arctic Region Units. DA (Deferred to the Statewide 2012 meeting as amended to apply statewide.) Regional Reauthorize the current resident tag fee exemptions for brown bear in Units 18, 22, 23 and C 34 26A. **Other Units** Approve an intensive management plan for moose in Unit 15A. (Deferred to the Statewide, 35 2012 meeting.) D Approve an intensive management plan for moose in Unit 15C. (Deferred to the Statewide, 36 2012 meeting.) D Amend the current predation management plan for the Southern Alaska Peninsula caribou 37 CA herd in Unit 9. (Change "viable" to "sustainable" in paragraph 4F.) Repeal the statewide definition for an ADF&G style breakaway snare; modify and add the CA requirement to trapping in the Gustavus area. (Delete the portion of 92.095(16) that defines the style of trap.)

Other Actions:

The Board found a positive finding for customary and traditional use of Ptarmigan in Unit 22 and set the ANS (Amount Reasonably Necessary for Subsistence) at 125-900.

The Board found a positive finding for customary and traditional use of Ptarmigan in Unit 18 and set the ANS (Amount Reasonably Necessary for Subsistence) at 3,000 - 23,000.

The Board agreed to send a letter to USF&WS to comment on the draft ANWR Comprehensive Conservation Plan.

The Board set the meeting locations for the 2012/2013 cycle as follows:
