## **Dalton Highway Area Authorized Stream Locations**

ADVISORY: Numerous waterbodies and portions of waterbodies in the Dalton Highway Area are managed by the BLM; suction dredging is prohibited by the BLM unless you have an approved mine plan on an existing federal mining claim. Generally, for all streams listed as "Streams/Portions of Streams Managed by BLM" you can assume that suction dredging is prohibited. Some of the streams listed as authorized may be partially managed by BLM and suction dredging is prohibited in those areas. You are advised to contact the BLM at (907) 474-2200 for more information before going to the field.
