The board closed specific commercial harvest areas if sport fishing in the Chuitna is closed, and further prescribed sport fishing closures in the Chuitna, Lewis, Beluga, and Theodore River drainages, including closures to catch and release.
- C **Proposal C:** Regulatory action regarding Willow and Goose Creek King Salmon Action Plan. The board removed the final weekend from streams in Unit 2 of the Susitna River drainage area and closed fishing from 11:00 p.m. to 6:00 a.m. Additionally, in the Goose Creek drainage, sport fishing was closed for king salmon.
- C **Proposal D:** Regulatory action regarding Alexander Creek King Salmon Action Plan. The board prohibited the live release of Northern pike in the Susitna River drainage and West Cook Inlet Area, removed size and bag limits on Alexander Lake, and allowed the use of spear and bow and arrow on Alexander Lake.
- C **Proposal E:** Inriver goal and optimum escapement goal (OEG) for Kenai and Kasilof sockeye salmon. The board converted escapement goals for enumeration with DIDSON sonar.
- C **Proposal F:** Tyonek Subdistrict Subsistence Finding. The board specified the amounts necessary for subsistence of king salmon and other salmon in the Tyonek Subdistrict as 700-2,700 king salmon and 150 - 500 other salmon.
- C **Proposal G:** The board defined "fishing period" in the Cook Inlet Central District as a period open to commercial fishing not to exceed a 24-hour calendar day. This was done to clarify application of the "one percent rule".

## OTHER

Board of Fisheries delegated authority to the commissioner for correcting the regulatory definition of personal use fishing for consistency with AS 16.05.940(25).

The board chose to draft written findings regarding the specific regulatory actions taken to address stocks of concern for review and adoption during its March 22-26, 2011 meeting.

The board asked Chairman Webster to draft a letter to the North Pacific Fisheries Management Council regarding the recent increase in bycatch of Chinook salmon in the Gulf of Alaska.

The board reviewed a petition from the Southeast Alaska Fishermen's Alliance regarding problems with acquiring nets with the proper size mesh for use in the West Behm Canal herring fishery. The board delegated authority to the commissioner for developing an emergency regulation allowing use of 2 1/8-inch mesh nets.

The board discussed board member scheduling conflicts with the currently scheduled October 2011 and December 2011 meeting dates. The new preferred meeting dates are October 7-13, 2011 and December 4 -9, 2011. Staff was asked if meeting locations could be found in the downtown Anchorage area.

The board asked for a presentation during its March 22-26, 2011 meeting on the Susitna Hydropower Project as it relates to fish habitat.
