







#### PWS Commercial Tanner Crab Area Map




#### PWS Commercial Tanner Crab Fishing Districts

## PWS Noncommercial Tanner Crab Regulations

Prior to 1999

- Sport, Personal Use, and Subsistence
- Open year round
- 20 male crab ≥ 5.3 or
  5.5 inches
- 10 pots per vessel
- No direct monitoring
- Area closures by EO

2008 to Present

Subsistence only

October 1<sup>st</sup> – March 31<sup>st</sup>


5 male crab  $\geq$  5.5 inches

2 pots per vesselPermit requirementKey areas closed


## PWS Noncommercial Tanner Crab Harvest

- Prior to 1999, no direct harvest monitoring
  - Statewide Harvest Survey 1994-1998
    - Average of 300 crab
  - Subsistence Surveys
    - < 4,900 Tanner crab in 1997


#### PWS Subsistence Tanner Crab Current Fishery Harvest and Effort




#### PWS Subsistence Tanner Crab 2012/13 Season Harvest



#### PWS Subsistence Tanner Crab Permit Holders Residence




### PWS Commercial King Crab Harvest and Effort



## PWS Noncommercial King Crab Harvest

- Prior to 1999, no direct harvest monitoring
  - Statewide Harvest Survey 1994-1998
    - 1997: 27 king crab
    - 1998: 52 king crab
  - Subsistence Surveys
    - < 150 king crab in 1997

# **PWS Tanner and King Crab Proposals**

#### Proposal 327:

Move the king crab western boundary of the PWS area west, to standardize the boundary line across commercial fisheries and to coordinate with the Area K eastern boundary

#### **Proposal 328:**

Move the Tanner crab western boundary of the PWS area west, to standardize the boundary line across commercial fisheries and to coordinate with the Area J eastern boundary

#### Proposals 329, 330, 331, 332, and 333:

These 5 proposals each seek to open a commercial Tanner crab fishery within PWS, with differing seasons, vessel length restrictions, and gear limitations
