My name is John Murray and I live in Sitka and have trolled out of Sitka since 1978.

I offer these comments as public testimony.

I wrote Proposal 223 as a starting point to make a change in 5AAC 29.100 Management of the Summer Troll Fishery from the existing 70/30 split for King salmon (70% in July 1st opening and 30% in second or August opening) to a 60/40 split (60% in July 1st and 40% in the second August opening).

Proposal 223 will only allow the 60/40 split of our summer chinook in seasons of higher abundance, i.e. 1.60 Abundance Index and above. It would remain 70/30 when the Abundance Index is below 1.59.

Since 1994, the Abundance Index of over 1.60 and above occurred in 9 out of 21 seasons, leaving 12 seasons below the 1.59 Abundance Index. I offer this as historical information.

This Proposal would move 10% of the harvestable summer chinook to the second opening in higher abundance seasons. This equates to a range of 8k to 25k fish moved to the second chinook opening which occurs in mid to early August.

I believe this Proposal is in agreement and an improvement on the 1992 Board of Fish Task Force charge which was set up to design a management plan that would:

- ensure a summer troll chinook salmon season of at least 10 days, preferably 20 days;
- 2) minimize the incidental mortalities of chinook salmon to the greatest extent possible;
- 3) maximize the value of the troll product; and
- 4) recognize the historic composition of the fishery.

Vhat is the issue you would like the board to address and why? I would like to amend AAC 29.100(c)(1)(A) and (2)(A) and (2)(B) to take 60 percent of the remaining king salmon arvest if the preseason abundance index is above 1.60 (70 percent is in existing regulations and rould remain in effect if the preseason abundance index is below 1.60). The five reasons to ecrease the percentage to 60 percent harvest of king salmon on high abundance seasons are:

- 1. Higher value for king salmon in late season;
- 2. Higher quality product;
- 3. Minimizes the incidental hook & release of king salmon;
- 4. Spreading the income derived from king salmon more evenly among the fleet; and
 - 5. Greater opportunity for in-season management during the August opening
